I guarantee this Akita to the best of my knowledge to be of sound body, good health and free of any communicable disease at the time of sale/placement. Client has three working days from the date on this contract to take the Akita to the veterinarian of their choice. If at this time the veterinarian finds serious illness, it can be returned to Moonlight Akitas for a replacement or refund at the discretion of Moonlight Akitas.

As long as this Akita stays with the client and the prefix "Moonlight" is used on the AKC registration papers, this Akita will be guaranteed to the age of three (3) years to be free of any disqualifying faults as named by the AKC breed standard and to the age of seven (7) years to be free of any genetic disease, which must be the result of genetic origin and not the result of environmental factors (poor nutrition, accident, or illness). Tests for genetic diseases must be performed before this Akita is used for breeding purposes. If the Akita is found to have a fault or genetic disease by an approved licensed veterinarian or the OFA, in the case of eye disease a veterinarian ophthalmologist, it will be replaced with an Akita of equal or greater quality as soon as one is available. Replacement will only occur after Moonlight Akitas receives written certification from a veterinarian stating that the Akita has been sterilized. No other guarantee is made. No money will be refunded in whole or in part for any reason.

Client agrees to provide regular veterinary care, proper food, water, shelter and adequate companionship. Client also agrees that this Akita and its offspring will not be used to produce offspring intended for or sold to any pet shop, wholesale or retail outlet, dog agent or dog dealer, or dog fighting places or people. \_\_\_\_\_ (initial)

Client agrees to return Akita to Moonlight Akitas if Client is unable to keep Akita. Client agrees to notify Moonlight Akitas of any change in address and/or telephone number. \_\_\_\_\_ (initial)

Client understands when they purchase a show Akita from Moonlight Akitas it is with the understanding that this Akita will be shown to its AKC championship prior to breeding. Client agrees this Akita will only be bred to Akitas of show quality and free of disqualifying faults and genetic disease (OFA'd & Cerf'd). Offspring of this Akita shall not be sold with breeding privileges unless they are of show quality. Companions are to be sold with a spay/neuter agreement and with no breeding privileges on the AKC registration papers. \_\_\_\_\_ (initial)

Client agrees to attend obedience class with this Akita within six months of the date of this contract. Client must understand that obedience class is necessary in teaching responsible dog ownership and proper socialization of the Akita itself. \_\_\_\_\_ (initial)

Client understands he/she is solely responsible for this Akita and to indemnify and hold harmless Moonlight Akitas from any and all claims of liability for the conduct of this Akita on or after the date of this contract. \_\_\_\_\_ (initial)

Violation of this contract damages the goodwill and reputation of Moonlight Akitas and the Akita breed in general. Breach of this contract can result in repossession without reimbursement.

Male Akita:

\_\_\_\_\_ Stud Right(s) are used by Moonlight Akitas to any female Akita that Moonlight Akitas owns, co-owns, or leases. A Stud Right is defined as the breedings necessary to occur between this Akita and the Akita presented that produce two or more live puppies at eight weeks of age. \_\_\_\_\_ (initial)

If Moonlight Akitas collects semen for freezing, it will be done at Moonlight Akitas expense and each collection will be considered one of the Stud Rights. Any semen that is collected and stored by Moonlight Akitas is considered property of Moonlight Akitas with all rights thereof.
